The research aims to examine trends, processes and dri-
vers of migration and displacement in and from Darfur, with
a particular focus on migration flows during its protracted
conflict. The research will provide insights into current mo-
bility patterns, explore the reasons for migration and displa-
cement, how it builds on past migration patterns, and the
decision-making processes of actual and potential migrants
and refugees. The findings will lead to better understanding
of the recent changes in migration flows, in particular to-
wards Europe, and of the effect of current interventions tar-
geting migrants. The study also aims to identify appropriate
responses to reduce levels of irregular or unsafe migration
or create opportunities to stay safely at home. This propo-
sal provides the justification for doing the research, the pro-
posed research questions, methods, timeframe and bud-
get. It also provides background information on the nature
and types of migration in Darfur.

d’étudier les dispositifs pédagogiques développés dans ce
contexte ; d’analyser différentes situations d’échange, voire
de controverse, autour de la légitimité des savoirs sur les
oiseaux et les zones humides et d’interpréter les représen-
tations graphiques ainsi que les discours concernant les
espaces protégés et les différents acteurs impliqués dans
le processus de conservation.

Dr. Griet Steel (Utrecht University) will be the co-PI for a DFID funded research project, led by Gordon Mc Granahan (IDS Sussex), entitled “**The urban land nexus and inclusive urbanisation in Dar es Salaam, Mwanza and Khartoum.**” This action-oriented project will use the urban land nexus and its politics to provide the entry point for analysing the cities of Dar es Salaam, Mwanza and Khartoum as integrated city systems. The objective is to identify, research, and stimulate policy debate on changes that are politically feasible and scalable, and foster more inclusive and welfare-enhancing urban transitions. Particular attention will be paid to the gender, class and migratory dimensions, and the challenges and opportunities posed by urban informality and hybrid governance. The approach will be multi-disciplinary, with systems and political economy perspectives, along with mapping tools, providing the unifying framework.

Transient Students & Researchers

Anael Poussier, PhD student in history, Université Paris 1-Sorbonne, as joined CEDEJ-Khartoum as a new Associate. Anael arrived in Khartoum in July 2017. After having worked on the Anglo-Egyptian garrison of Sawakin between 1883 and 1891 for his Master in History, he has chosen, with the help of his supervisor, Mr. P. Vermeren (University of Paris I - Sorbonne), to focus his research on the interactions between regional actors in the Sudan and the central government during the Mahdiyya. He has been studying the different dynamics of tribal mobilization that can be witnessed in the Sudan at that time, quite particularly in the Eastern Sudan. The research aims at emphasizing the complex and fluctuant connections between socio-economical factors and tribal adhesion to the Mahdist movement. He is thus particularly interested in the Mahdist correspondence which should enable to define the nature of those relationships.

Matthew Benson is a PhD candidate in Durham University's Department of History and has joined CEDEJ-Khartoum as a new Associate. His research combines descriptive statistics with an analysis of archival sources to examine how people have experienced, and shaped, public authority in South Sudan & Sudan by complying or contesting taxes in the country.

This research builds on Matthew's experience examining the links between tax and state-building in post-CPA South Sudan, and the political economy of tax reforms in post-conflict countries more broadly, with the Institute of Development Studies at the University of Sussex. It is also informed by field postings in South Sudan with Crown Agents and Sudan with Doctors Without Borders/Médecins Sans Frontières (MSF). Matthew has also conducted field research in Uganda and undertaken research assignments with the Overseas Development Institute, the World Bank, the UN Refugee Agency and Oxfam America.

Matthew was researching relevant files in the National Records Office and will also be giving a presentation on his research at the University of Khartoum on 15 June 2017 (location TBA).

Christina Gregory is a PhD student from the University of California, Riverside, Department of Political Science. Her research looks at the Sudanese military after the first civil war. She is interested in the way southern forces were integrated into the national military and what the military was like in terms of demographics leading up to the first civil war and during the 1970s up till the second civil war starts.
